

Terms and Conditions
SONY ALPHA FEST '25 PHOTO CONTEST

Sony Electronics (Singapore) Pte. Ltd., ("Sony") maintains <https://www.sony.com.sg/microsite/AlphaFest/index.html> ("Site") and is responsible for organising Alpha Fest Theme contest ("Contest"). By entering and participating in this Contest, participants agree to be bound by and to comply with the terms and conditions of the Contest ("Terms and Conditions") and the decisions of Sony in relation to and in connection with this Contest. Sony reserves the right to cancel and/or amend the Contest and the Terms and Conditions at any time without prior notice. Any changes will be posted on the Site.

Eligibility

1. The Contest is open only to people of any nationality lawfully residing in Singapore who are 18 years or older as at the date of participation and during the Contest Period ("**Eligible Participant**"). For the avoidance of doubt, participation refers to submission of photos for the Contest.
2. Notwithstanding the above definition of "Eligible Participant", employees of Sony and its affiliates in Singapore, advertising and promotion agencies of Sony together with their employees, Associated members of Sony and immediate family members and/or those living in the same household of each of the aforesaid persons are not eligible to participate in this Contest. "Associated members of Sony" in this context refers to Sony contracted coaches and their related staff.
3. Sony reserves the right to disqualify and/or exclude any entries or participants from the Contest, for any reason and for no reason, including without limitation, violation of any portion of these Terms and Conditions.
4. You warrant to indemnify Sony against any and all claims in relation to your participation of this Contest and breach of its Terms and Conditions contained herein. Sony's rights are hereby expressly reserved.

Contest Period

5. The Contest is from **17 October 2025 to 19 October 2025** ("**Contest Period**"). Sony shall not be liable for any entries that are sent by Eligible Participants but not received by Sony during the Contest Period for any reason.

Contest Mechanics

6. **How to Enter**

The photo contest theme and the relevant hashtags will be announced on @SonySingapore's social media channels and on Site on 17 October 2025 at 2PM.

To enter the Contest, the Eligible Participant must complete the following:

Photo Contest:

STEP 1: To take photos with Sony products based on the theme "Wanderlust"

STEP 2: To post the photos on their Instagram account by **19 October, 4PM**, and the post must include the relevant hashtags (#AF25_Contest and #SonyAlphaFest25SG) and tag @sonysingapore. Each Instagram post may include up to 5 photo entries. The participating Instagram profile must be set to public.

7. **Submission Requirements**

- i. Submitted photo entries must be shot with any Sony Alpha camera, Sony lens or Xperia phones ("**Sony Gear**"). Any submitted photo entry must be verifiable that it was taken by a Sony Gear.
- ii. Photo submission must be submitted within the Contest Period. For the avoidance of doubt, it is not a requirement for the photo submitted to have been taken during the Contest Period, photo taken outside of the Contest Period are eligible.
- iii. Editing of photo entries are allowed, but excessive digital imaging / post-treatments are discouraged.
- iv. Participants may only submit more than 1 Instagram post per participant and each post may include up to 5 photo entries. If the participant submits more than 5 photo entries in a single post, Sony may disqualify any or all of the photo entries and/or posts.
- v. Shortlisted photo entries will need to submit the original photo for verification and review of metadata, including capture date and time.

8. **Selection of Winners**

- i. All eligible entries (entries with vulgar and malicious content will not be considered) will be judged based on relevance to the theme by Sony's selected judging panel comprising of Sony Alpha Professionals and Creators (as listed on the Site).
- ii. A total of 3 winners will be selected. The announcement of the winners will be notified via Instagram Direct Message and announced on Site by 9PM on 19 October 2025..
- iii. We reserve the right in our sole discretion, to edit or delete any documents, information or other content appearing on the site including disagreements, without any notice requirement or obligation to you.
- iv. The winners shall agree to be contacted by Sony and/or its authorised representatives to facilitate media enquiries. This may include, but not be limited to, quotes given for inclusion in press releases and press conferences, interviews, etc.

Prizes

9. Subject to the terms and conditions herein, the winner(s) of the Contest shall receive the corresponding listed prize(s) ("**Contest Prize**") below from Sony:
 - Grand winner x1: SGD500 Sony Store Voucher + Alpha Logo Hot Shoe Cover (Gold) + Alpha Logo Hot Shoe Cover (Silver)
 - Runners-up x2: SGD200 Sony Store Voucher + Alpha Logo Hot Shoe Cover (Silver)
10. The Contest Prize is non-transferable and non-exchangeable for cash or credit and are subject to availability. Sony reserves the right to replace any Contest Prize with items of similar value without prior notice.
11. Acceptance of any prize shall constitute consent on the winner's part to allow the use of the winner's name, image, voice and/or likeness by Sony for editorial, advertising, promotional, marketing and/or other purposes without further compensation except where prohibited by law. Contest Entries

21. Submissions: (i) must be in the English language or accompanied with an English translation of the audio or visual text; (ii) must be the exclusive original work of the Eligible Participant; (iii) may not be inappropriate, offensive, libelous or defamatory, pornographic, sexually explicit, unlawful or plagiarized, as determined by Sony in its sole discretion; (iv) must not be harassing, abusive, threatening, harmful, vulgar, profane, obscene, excessively violent, racially, ethnically or otherwise objectionable or offensive in any way, as determined by Sony in its sole discretion; (v) may not violate or encourage others to violate any applicable law, statute, ordinance or regulation; (vi) may not defame or invade publicity rights or privacy of any person, living or deceased, or otherwise infringe upon any person's personal or property rights or any other third party rights; (vii) may not contain commercial or corporate advertising, other than those relating to Sony; (viii) may not include any website URLs, viruses, worms, corrupt files, Trojan horses,

or other forms of corruptive code or content that may harm or compromise the proper conduct of the Contest; (ix) may not use any watermarks or distinguishing artist marks (such as signatures); and (x) if found to be in violation of these Contest Rules will be disqualified and therefore removed from the Contest.

22. By submitting an entry, Eligible Participant represents that (i) he/she has the unrestricted right to submit the entry; and (ii) the entry does not infringe upon any third party's proprietary or other rights. No damaged, incomplete, forged or appropriated entries will be accepted.
23. 24. Any costumes, props or other materials used must be rented or borrowed with the permission of the owner, and all other relevant permissions must have been obtained.
25. Participant guarantees that any enhancement is made via use of legally acquired software.
26. Participant guarantees that any audio files added to the videos are obtained legally.
27. Videos that use Augmented Reality (AR) effects applications (TikTok, SnapChat, Boomerang & etc.) will be excluded from joining this Contest. The video is allowed light retouching but cannot be digitally manipulated such that the video will be deemed unrealistic and/or untruthful.
28. You shall hold Sony and all of its officers, directors and employees free and harmless from any liability arising from claims or suits of third parties, including costs and expenses incidental thereto, in connection with the use of the Contest videos, photos and/or entries.
29. Where there are images or personal information of other individuals appearing in or associated with your entry, you confirm that the individuals have consented and agreed to you providing the images and personal information to Sony and that Sony may use the images and personal information for the purpose of this Contest.
30. Sony reserves the right to disqualify all entries that do not meet the rules and regulations of the Contest. These include entries submitted with invalid or incorrect information.
31. Unfair or unethical methods of participation may result in disqualification.
32. Sony's decision for the winner is final.

33. By submitting the entry, you agree and warrant that you shall not submit any content (a) that is hateful, threatening, or pornographic; incites violence; or contains nudity or graphic or gratuitous violence; (b) that violates any law, statute ordinance or regulation (including, but not limited to, those governing export control, consumer protection, unfair Contest, anti-discrimination or false advertising); that is, or may reasonably be considered to be, defamatory, libelous, hateful, racially or religiously biased or offensive, unlawfully threatening or unlawfully harassing to any individual, partnership or corporation; (c) on behalf of any merchant or manufacturer, or for which you were compensated or granted any consideration by any third party; (d) that includes any information that references other apps, addresses, email addresses, contact information or phone numbers; (e) or that contains any computer viruses, worms or other potentially damaging computer programs or files.
36. 39. Please be advised that all materials posted on the Site are subject to public downloading by third party viewers. Sony has taken precautionary steps to deter users from downloading. However, should downloading persist, Sony shall not be held accountable or liable for any damages caused.

Privacy Policy

40. Information - When using the site, you may be asked to enter information including personal information ("**Information**"). The Information will only be used for the purposes set out in these Terms and Conditions, for the purposes explained when you have been asked to enter the Information and/or in accordance with this Privacy Policy and the Data Protection Policy of Sony (<http://www.sony-asia.com/section/privacypolicy>).
41. Provision of Information to Third Parties - We will not sell or otherwise transfer the Information to unaffiliated third parties without your approval. If applicable, you will have the opportunity to indicate whether you would like to "opt in" and/or "opt out" to receiving promotional and/or marketing information about other products, services and offerings from us and/or any third parties.
42. Analysis of User Behaviour - We reserve the right to perform statistical analyses of user behaviour and characteristics in order to measure interest in and use of the various areas of the Site and to inform advertisers of such information as well as the number of users that have been exposed to or clicked on their advertising banners. We will provide only aggregated data from these analyses to third parties. We are not responsible for any actions or policies of any third parties who request personal information, and you should check the applicable privacy policy of that party.
43. Cookies - You should be aware that information and data may be automatically collected through the use of "cookies". "Cookies" are small text files a site can use to recognise repeat users and allow us to observe behaviour and compile aggregate data in order to improve the Site and to target its advertising. Cookies do not attach to your system and do not damage your files. If you do not want information collected through the use of cookies, there is a simple procedure in most browsers that allows you to deny or accept the cookie feature.
44. Updating or Removing Information - You may notify us of any updates, amendments and corrections to previously collected Information by using the Feedback Form on the Data Protection Policy. Further, upon your request, we will use commercially reasonable efforts to delete your Information from our database. However, it may be impossible to delete your entry without some residual information because of backups and records of deletions.
45. Changes to this Policy - We reserve the right, at any time, to modify, alter, or update this Privacy Policy.

Miscellaneous

46. Sony reserves the right, in its sole discretion, to terminate or suspend the Contest without any liability to you should there be unforeseeable events which in Sony's absolute opinion may jeopardize the process of the Contest.

47. Sony reserves the right to amend/change the Terms and Conditions and the prizes without any liability to the Contest participants.
48. In the event of disputes regarding the Contest or the Terms and Conditions, Sony shall have the right to make the final decision.
